ORDER

While considering the proposal submitted by the School management for the academic year 2018-19, it appears that the fees proposed by the School management is at higher side. The fees proposed by the School management deserves to be substantially reduced. This Committee, therefore, determines the provisional fees for the academic year 2018-19 as under:

It is needless to state that the Committee has determined the provisional fees for the academic year 2018-19 by giving 5% rise in the fees determined for the academic year 2017-18.

Terms and Conditions.

1. It is made clear that School is not permitted to collect fees for the first quarter of 2018-19 more than the provisional fees determined for the year 2018-19.
2. It is further made clear that school is not permitted to collect fees under any other head including under the head Admission fees or term fees and thereby causing any extra burden on the students.



3. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
4. This provisional fees determined by the Committee shall be subject to the final determination that may be made by the Committee, after considering the objections received by the committee, if any and as may be altered, amended or modified either by the Fees Revision Committee or by the Hon'ble Supreme Court of India in appropriate proceedings.
5. The Committee has considered the provisional Fees for the year 2018-19 with 5% rise therein for the year 2019-20.
6. If any school is aggrieved by provisional fees determined by the committee, it shall raise an objection before the committee within 7 days from the date of receipt of this order.
7. You are requested to place the order determining provisional fees on your notice board as well as on Website and if you receive any objection against the provisional fees from any parent, please send the said objection along with your objection.
