(1) Tapovan Vidhyalay, Near Subhlaxmi Apprtment, Sanghvi School Cross Roads, Naranpura, Ahmedabad – 380 013, has filed its proposal for Academic Year 2024-25 for Pre Primary, Lower Primary, Upper Primary and Secondary Section (Std. 9th & 10th) (CBSE – English Medium) along with relevant documents. We have gone through the papers submitted along with proposal. It appears that the school has produced accounts for the year: 2021-22, 2022-23 & 2023-24. The school has also produced estimated expense for the year: 2024-25. It appears that the strength students is 943.

- (2) It has come to the notice of this committee that after the judgment of Hon. High court of Gujarat in special civil application No. 2356/2021 dated: 22-07-2022, many schools have started to collect additional term fees extra. We have not found any clarification that whether this applicant school has collected two months term fees over and above the fees determined by the committee or not.
- (3) FRC has considered section 10(3) of "The Gujarat self financed schools (Regulation of fees) Act. 2017", which is reproduced as under.

The fee regulatory committee shall determine the total fees which shall be levied by considering all different fees charged by the school.

- (4) The committee has also gone through the judgment delivered by Hon. High court of Gujarat in SCA No. 2356/2021 dated 22.07.2022.
- (5) The School has filed audited account for the year: 2023-24, which is certified by C.A., Looking to the Statement and on verifying the above statement it is found that some of the expenses like Activity Expenditure, Amount disbursed to any Agency or Company regarding school Activity,

Expenditure on Maintenance, Expenditure on Transport, Expenditure on Uniform, Expenditure on House keeping, Expenditure on examination and Miscellaneous Expenditure etc. are either higher sides and not justifiable because they are either excess or without explanation hence found disallowable and not for education purpose. And by considering the strength of the student's it is found that the proposed fee structure is not found satisfactory. But looking the teacher's salary some reasonable fee structure determines by the FRC.

(6) Considering the above facts and audited I & E Statement, We determine the fees for the A.Y.: 2024-25 as under.

:: Terms and conditions ::

(1) The School shall not collect fees amounting to more than one quarter at a time.



- (2) It is also made clear that the school should either return the excess fee collected by the school or give adjustment thereof, in the fees in the next coming academic year without fail.
- (3) It is directed that the school is not permitted to collect fees for the any year, more than the provisional fees determined by the FRC for the above years, except permissible.
- (4) Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- (5) If the school is aggrieved by the provisional fees determined by the committee, the school has a right to file objections before the committee within 7 days from the date of receipt of this provisional order.
- (6) The School is directed to place the final order determining the final fees on its notice board as well as on its website in English and Gujarati language.
- (7) If the school has no objection for the above provisional order, then treated above order as final order.
