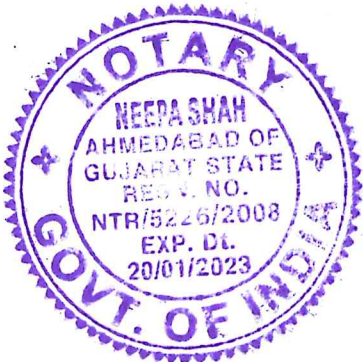

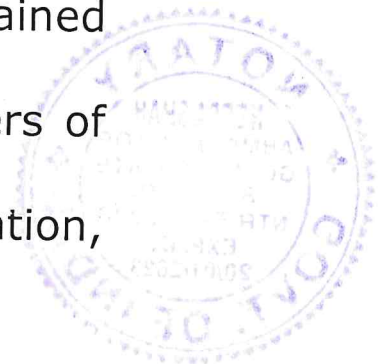



In pursuance to the above subject matter and with reference to the letter mentioned in the Reference - 1 hereinabove, proposal has been made to change the name of Nishkal School of Thoughts (English Medium) administered by Smt. Diwaliben Ambalal Charitable Trust, Vijaynagar Road, Naranpura, Ahmedabad to Tapovan Vidhyalaya. For which, a personal hearing was kept in this office with regard to the same on Date : 28/6/2017, wherein Prakashchandra C. Shah had remained present. On asking him, some of the members of the said Trust having tendered their resignation,






copy of the P.T.R. of change in the members of the Trust made with the Office of the Charity Commissioner, Ahmedabad was submitted. The below mentioned order is being passed relying upon the copy of the P.T.R. and the submitted evidences.

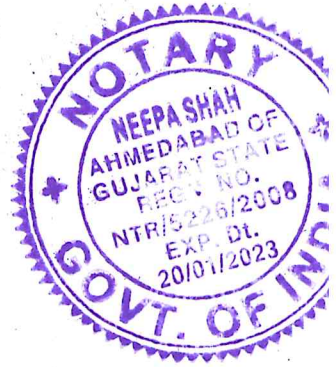


Nishkal School of Thoughts (English Medium) administered by Smt. Diwaliben Ambalal Charitable Trust, Vijaynagar Road, Naranpura, Ahmedabad has been initially granted permission in the year 2002 for running one class of each for Standard 1 to 7. In which school, due to lack of numbers of students, the same was closed. But submissions were being made to re-start the School by the neighbouring students and guardians. Therefore, the administrative board of the School and the guardians / parents of the students had made





submission to re-start the school for the purpose of granting admission to the students of its school and to change the name of the School. Looking at all these details and taking into consideration the interest of the students and the guardians/parents, order is hereby passed to re-start the School by starting first one - one class of Standard 1st to 7th (English Medium) of Nishkal School of Thoughts, Vijaynagar Road, Naranpura, Ahmedabad from June - 2017.



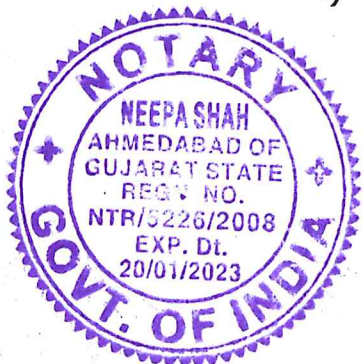

- 4) The liabilities with regard to all the financial, administrative, legal and all old claims or pending cases would be that of the Trustee Board.
- 5) The place of the School would remain the same.
